
Eligibility

1. The bidder must have a valid PAN & GSTIN.
2. The bidder must have a vehicle in its own name.

The bidder must agree & fulfil the following terms & conditions to provide vehicle on daily rent basis on demand (as and when required)

Terms & Conditions:

1. The engagement of hired vehicle on demand (as and when required) shall be for a period of one year from the date of execution of agreement with the undersigned.
2. The hired vehicles provided on demand should not be older than five years from the date of initial registration. During the hiring period, all necessarily valid MV documents such as: Valid Registration Certificate, Insurance Certificate, fitness Certificate, Valid Contract carriage permit, up to date tax payment etc. and D.L of the driver shall be available at all the times with the driver of the vehicle.
3. The department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any property on account of use of hired vehicle in any manner whatsoever. The vehicle owner/bidder shall be held responsible for all such litigation.
4. The hire charges and DOL consumed to be paid after submission of bill. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating engine oil etc will be borne by the bidder.
5. It shall be responsibility of the bidder to provide a good driver and the salary/wages of the driver shall be borne by the owner.
6. In case of break down for reasons whatsoever the replacement of the same or better model shall be provided by the owner of the vehicle on the day of requirement.
7. The plying/running of the vehicle will be counted from the office of the undersigned located at Koraput.
8. In case, if in any occasion any other vehicle is available at lowest/cheaper rate, the vehicle available at lower rate shall be engaged in that occasion and the bidder should not claim for engagement of his hired vehicle in that case.
9. The successful bidder has to sign an agreement with the undersigned in a non-judicial stamp paper worth Rs. 10/- for empanelment of engagement of vehicle.
10. The vehicle must have minimum fuel efficiencies for Bolero/Scorpio/Ertiga 10 KM for AC and 12 KM for Non-AC and for Innova 8 KM for AC and 10 KM for Non AC and for other Cars ie. Swift/Desire etc 14 KM for AC and 15 KM for Non AC.
11. The lowest quoted rate towards hire charges of vehicle will be considered for empanelment and engagement as and when required.
12. The hiring charges quoted per day shall be inclusive of all taxes and duties.
13. Either party has the right to de-empanelled by giving one months notice.
