TENDER CALL NOTICE

1) The Sub-Collector Jeypore-cum-Chairman Regulated Market Committee, Jeypore invite rate quoted bid in sealed cover from reputed manufacture/ authorized registered dealers for supply, installation and commissioning along with AMC charges of grading equipment viz **(1) Electronic Weighing scale 300 KG Capacity (without printer) (2) Analysis Kit (3) Sample Divider (burner type) (4) Set of sieves (5) Digital Moisture Meter (with printer) of latest version with Compatible Bluetooth & USB connection** which can be paired with other devices and according to the specification given by OSAM Board, Bhubaneswar vide **Letter No.1729 (66) dt. 20.08.2019 of General manager OSAM Board** in plain paper with proper format and seal & signature within the specified time period.

2) The bidder should be an original Manufacturer or Authorized Dealer of the equipment/ items stated above and capable of providing adequate & timely after sales services. Necessary proof towards bidder being a Manufacturer or it's Authorized Dealer should be submitted along with bid.

3) The bidder should have successfully supplied these products for agricultural marketing appliances in Odisha or in any other State/ institute/ Organizations.

4) The bidder should submit attested xerox copies of valid Manufacturer/ Dealership Registration Certificates, GSTIN, GST Clearance certificate & PAN Card and authorization certificates (if not an original manufacturer) etc. along with the bids.

5) The Bid document must be enclosed with an EMD amount of Rs.100,000/- (Rupees One Lakh) only in shape of Demand Draft drawn in Nationalized Bank paybale at jeypore in favour of Regulated Market Committee, Jeypore.

6) The Bidders should enclose detailed write-up along with necessary technical specification/ documents/ drawings and designs for all the makes and models in the bid.

7) The Tenders/ bidders having ISO certification shall be given preference over others, for which bidder may submit documentary evidence towards same along with bid.

8) No conditional offer/ undertaking will be accepted.

9) All exemption will be strictly applicable as per rules of Govt. of Odisha.

10) Eligibility Criteria : in case of Electronic Weighing Scale 300 Kg. Capacity it is of plain type without printer facility. It should be duly verified and stamped by Legal Metrology Department, Govt. of Odisha for the first year.

11) All price quoted should be inclusive of all taxes and delivered at R.M.C. destination point.

12) All instruments should be covered twelve months of warranty.

13) The bidder should quote the AMC rate for each item for three consecutive years after successful completion of warranty period.

14) The successful bidder must supply the instrument within 7(Seven) days of issue of supply order failure to which the supply order will be cancelled and bidder will be black listed.

15) Legal Metrology license like Manufacturing, Dealership, Repairing & Model approval issued by Directorate of Legal Metrology Department, Govt. of Odisha should be attached with bid.

16) The bid in sealed envelope should be submitted in the office of the R.M.C, Jeypore before **5.00 P.M on dated. 24/10/2024** in **office box** or through **Registered Post** address to Sub-Collector Jeypore-cum-Chairman, RMC, Jeypore at Umuri (Phulabada) P.O. Railway Station, Jeypore. Dist. Koraput. Pin- 764001 which will reach the office of R.M.C, Jeypore by **5.00 P.M on dated. 24/10/2024**. The R.M.C will not entertain any bid received after the time and date fixed. The bids will be opened at **11.00 A.M on dated.25/10/2024**.

17) Bidders should depute their representatives for demonstration of different instruments on dated. **25/10/2024** at office of the R.M.C, Jeypore.


