QUOTATION CALL NOTICE FOR HIRING OF VEHICLE

Sealed Quotation are invited from reputed Travel Agencies/Tour Operators or Private Individuals for providing 01(one) No.TUV300/Bolero/Sumo Gold/Ertiga to Petrol/Diesel vehicles same or higher model vehicle having sitting capacity not more than eight including driver, which shall conform to the Terms and conditions (Annexure-II) for use in One Stop Centre meant for District Protect Officer Cell of D.S.W.O.Koraput on monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the Date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
25. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the DSWO, KORAPUT and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
26. The monthly rate of hire charges not more than Rs.22,500/- be quoted separately in the general bid information (excluding fuel and lubricants).
27. The vehicle must achieve a fuel efficiency of 10Kms. per liter.
28. The details of the make and year of manufacture of the vehicle, registration number, mileage (Kms. covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/ tender(Annexure-III)
29. The quotation completed in all respect should reach the DSWO,Koraput on or before 4.12.2024 by 4.00 P.M and shall be opened on the same day at 5.00 P.M in presence of the bidders or their authorized representatives.
30. The application form of Tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available on 27.11.2024 in the website www.koraput.odisha.govt.in.

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles during period of contract shall have all necessary valid MV documents such as: valid Registration Certificate, Insurance Certificate, fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicle shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract. The performance will be given to new vehicle.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdrawn the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant on month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms contract, Government shall forfeit the entire amount of security deposit.
