2. The bidder has to submit valid authorization certificates (s) from the manufacture/dealer/distributor for the items quoted. The bidder should producer proof of successful execution of similar nature of works.
3. The Supplier shall depute experienced persons for installation, commissioning and testing of equipments supplied.




