Aurobindo Purnango Sikhya Kendra, Pin- 764020 during office hour till 18.01.2025. The envelope containing the objection should be superscribed clearly "Submission of objection to the post of ..... in ..... School". Documents already asked for in the advertisement, if not submitted earlier, will not be allowed to deposit such documents afresh. The management will not be responsible for any postal delay in receiving the objection, if any.

Further, it is mentioned that, if a candidate has been placed in the provisional rejected application list for submitting graduation mark sheet/certificate graded on CGPA basis without submitting the CGPA conversion certificate, then the candidate is required to submit his/her conversion certificate or mark sheet issued by the institution within the objection period only so that his/her percentage score/ mark could be determined.

The objection received on or before the due date will be disposed off and the findings thereof will be made available in the above official website. No objection will be entertained after the date line under any circumstances.






