The bidders should submit bids in two envelopes, one containing a technical bid consisting of all technical details along with its experience and the other containing the financial bid indicating unit cost and total cost. The envelopes should be superscripted accordingly.

- (1) The Technical bid should contain the following.

  - (ii) The past performance
  - (iii) Technical competence
  - (iv) Production capacity


