1. (a) Fly Shuttle Frame loom with 5 wheel take-up motion & with 56"-60" Reed Space made up of seasoned Sal wood. Sley race & shuttle box to be made of Teak wood and other fittings with seasoned Sal/quality wood. Other specification is as per standard Odisha model.




