

- Bid documents consisting of specification, the bill of quantity, Tender call notice including the estimated cost, tender value, bid security/EMD, cost of bid documents, required class of contractor, completion time etc. are available in the e-procurement portal/ website <https://www.tendersodisha.gov.in>.
- The received bids shall be opened in the office of the Block Development Officer, Semiliguda on 17.05.2025 at 10.00 Hrs onwards. (if the office face electrical or Networking problem on the stipulated date of opening of Bids as specified, the bid will be opened on the next working day at same time and same venue).
- Bids/Tenders shall be deemed valid and hold good till 90 days from the date of obtaining of tenders.
- Class of eligible contractor in Column -05 registered with the state Government & Contractors of equivalent grades / class registered with Central Govt. / MES / Railways for execution of civil works. The proof of valid Contractor license should be enclosed along with the bid. The bidder must possess Compactable Digital Signature Certificate.
- The bidder has to upload the necessary documents as per the requirement asked in the bid. The bidder who are participating in the tender process are required to upload the scanned attested true copies latest IT clearance certificate, PAN, GST Registration certificate along with latest GST 3B form and valid contractor license supported with self attested copy and other necessary documents as mentioned in the online bid.
- Every Bidder/Tenderer must examine the detailed specification of the work before submitting his bid/tender. The right reserved without impairing the contract to make such increase or decrease in the quantities or items of work or deleting any item mentioned in the schedule attached to the tender notice, as may be considered necessary to complete the work fully and satisfactorily. It will definitely be understood that Panchayat Samiti, Semiliguda does not accept responsibility for the corrections or completeness of the quantities shown in the schedule. The schedule is liable to alterations, additions and deductions shall in no case invalidate contract and no claim for extra monetary compensation shall be entertained.
- The Percentage Rate shall be quoted in words and figures up to two decimal points only. Otherwise, the tender will be liable for rejection. In case of discrepancy between words & figure, the percentage rate quoted in words will be treated as final.
- Bidders/ tenderers are required to pay **Bid Security/EMD @ 1% (One Percent)** of the amount put to tender as mentioned in the **NOTICE INVITING TENDER** only in shape of NSC/KVP/Post Office Term Deposit / Term Deposit Receipt from any Nationalized Bank duly pledged in favour of the "Block Development Officer, Semiliguda". One EMD should be made for one work only. In no case one EMD should be utilized for more than one work. The Demand Draft/Bankers Cheque will not be entertained and liable for rejection. A true copy of the deposit of Bid security/EMD should be enclosed along with the tender documents uploaded online by the bidder failing which the Bids/Tenders will be summarily be rejected. The Bid Security/EMD to be refunded to the unsuccessful Bidders/Tenderers on application without any interest after acceptance of the tender and the same shall be retained in case of successful bidders/tenderers and shall carry no interest. The original in shape of NSC/KVP/Post Office Term Deposit / Term Deposit Receipt as mentioned above shall sent through Speed/Registered post along with other documents super scribing "Tender

9. The tender paper cost mentioned in Column -07 shall be deposited in shape of DD/Bankers cheque only to be drawn in favour of BDO, Semiliguda in any Nationalized Banks/Branch of Semiliguda. One DD/Bankers cheque should be made for one work only. In no case one DD/Bankers cheque should be utilized for more than one work. Any other mode of payment will not be entertained and liable for rejection. A true copy of the deposit of tender paper cost should be enclosed along with the tender documents uploaded online by the bidder failing which the Bids/Tenders will be summarily be rejected. The original DD/Bankers cheque shall be sent through Speed/Registered post along with other documents as detailed in point No. 8 above.
  10. The SC/ST contractor willing to avail the facilities as fixed by Govt. will upload affidavit as **Annexure- A** with self-attested copy of caste certificate, along with the tender documents, other wise they will not be entitle as such facilities and treated as general category with evaluate the bid on its own merit.
  11. The Engineering contract wills to avail exemption of EMD will submit the affidavit with declaration that he has not availed exemption more than 3 times for the F.Y. 2025-26 to avail the exemption along with bid documents.
  12. The Bidder shall have to furnish **No Relation Certificate** along with the tender as per the enclosed proforma in **Annexure-B**.
  13. The bid/tender of defaulting contractors (leaving the earlier works of Panchayat Samiti, Semiliguda incomplete and those contractors whose progress on Panchayat Samiti, Semiliguda works are unsatisfactory within the stipulated scheduled period) will not be considered till completion of the earlier works awarded by this Panchayat Samiti, Semiliguda.
  14. The bidders/tenderers whose bid/tender is selected for acceptance shall be intimated within a period of three days upon written intimation being given to him of acceptance of the tender shall deposit the initial security deposit amount equal to that of EMD and Performance security as applicable and sign the agreement. The Bid security/EMD amount will be forfeited if the bidder/tenderer back out from the offer of acceptance of tender by the competent authority.
  15. The work needs to commence immediately after award of tender. The authority reserves the right to award the tender to L2 Bidder (at L1 rate or which ever is lesser), if the work does not commence within the time awarded to the tenderer.
  16. The authority on behalf of Panchayat Samiti, Semiliguda reserves the right to reject any or all tenders received without assigning any reason whatsoever. The Panchayat Samiti also reserves the right accept any tender without assigning any reasons to other tenders.
