

If the Rate Quoted by the SC and ST Category Contractors comes to 14.99% (Decimals up to two Numbers will be taken for all practical purpose) less than the estimated cost after availing 10% price preference as per Para-1 of Works Department Resolution File No.07556900142018-16262/W, Dated, the **30th November, 2018**, the tender shall be finalized by the tender accepting authority through transparent lottery system alongwith other category of contractors whose rates are 14.99% less than the estimated cost in pursuance to the **Works Department Office Memorandum No.075569000162015-10224/W, Dated.01.09.2015.**


