



**4. Earnest Money Deposit (EMD/ BID SECURITY):**

The EMD/ BID security are required to protect the purchaser against the risk of bidders conduct, which would warrant the security's forfeiture. An **Earnest Money of 1% of the order of supply** in shape of A/C payee Demand Draft/ Banker's Cheque of a Nationalized Bank in favour of "**Deputy Collector, Emergency, Collectorate, Koraput**" payable at Koraput must be deposited along with the Quotation. The EMD should normally be valid for a period of 45 days beyond the final bid validity period. Please mention the item name & no. of the tender, your company name and address in the back side of the EMD draft for our reference. The **EMD to the unsuccessful Bidder(s) /Vendor(s) will be returned to them at the earliest (within 30 days) after expiry of the final bid validity or latest on or before the 30<sup>th</sup> day of the award of the contract or order whichever is earlier without any interest.** The earnest money of the successful Bidder /Vendor will be returned to them without any interest after completing the successful installation / delivery of boat in good and serviceable conditions. Bidder(s) /Vendor(s) exempted from applying EMD shall have to furnish the related valid documents for such exemption.

**4.1** Tender(s) without appropriate Tender Fee & EMD will be rejected at the spot of opening of the tender and no reconsideration will be made.


**4.2 The EMD/ Bid Security may be forfeited.**

(a) If a Bidder withdraws, modifies, revises, deviates from its bid or any of the terms and conditions of this tender enquiry document during the period of bid validity specified by the Bidder on the Bid Form: or

(b) In case of a successful Bidder, if the bidder fails to furnish order of acceptance within 30days.

**5. Tender Validity:** Till the end of current financial year i.e. 2025-26.

**6. Delivery:** To be delivered after trials at concerned River/ Ferry Ghat within 15 (Fifteen) days from the date of issue of order. The time frame for delivery is most important and should be strictly adhered to. Delivery of Boat should be made in good condition at the Ghat point, for which no extra cost should be made towards unloading / transportation, etc.

**7. Price:**

**8. Security Deposit:**

Security Deposit @ 5% of the basic Price of each boat will be deducted and kept from the payment which will be released after completion of guarantee Period. No interest will be payable for Security Deposit.

**9. Inspection and acceptance:**

**9.1:** Collector, Koraput or his authorised representative shall have the right to inspect the work at the construction site of the supplier for evolution of quality and progress at various stages of work. During inspection any defect are noticed the supplier shall make good all necessary alternations/ rectifications needed as per the specific requirement.


**9.3:** The boats shall be finally accepted/ taken over after inspection and running at specific ghat points.

**10. Guarantee:**

The supplier shall guarantee the performance of the Boats for a period of one year from the date of delivery against all manufacturing defects. Any manufacturing defects detected during the above said guarantee period shall be rectified free of cost by the supplier.

**11. Liquidated Damages:**

The work shall be completed within the stipulated delivery period, failing which liquidated damages for the delay @₹.500/- (Rupees Five Hundred) only per day will be deducted from the Contract value payable to the supplier and will be limited to a maximum of 5 (five) percent of the basic value.

- Original Demand Draft of **1% of the total order of supply** towards payment of **Earnest Money Deposit**.


**13. Miscellaneous:**
