Sealed quotations/tenders are invited from interested reputed Travel Agencies / Tour Operators / Private Individuals for providing 1no. of AC Petrol/Diesel driven vehicle having sitting capacity not more than 5 including driver, which shall conform to the Terms and conditions (Annexure-A) for official use in District Treasury, Koraput on monthly rent basis:

1. The service provider shall have a valid OGST registration to participate in the tendering.
2. The service provider, participating in the bidding process under the jurisdiction of Municipal Corporations, shall be registered on GeM platform.
3. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, valid Contract Carriage Permit, proof of up-to-date tax payment etc. mandatory for plying of vehicle.
4. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport/passenger vehicle.
5. The Driver should be well behaved, gentle and obedient in nature.
6. A sum of **Rs.5,000/-** shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Treasury Officer, District Treasury, Koraput** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
7. The monthly rate of hire charge is to be quoted separately in the general bid information (excluding fuel and lubricants) and it should be as per the norms outlined in Para 4 of FDOM No.22924 dt.14.08.2023 of Finance Department, Odisha, BBSR along with F.D. notification no15836 dt. 27.05.2025.

9. The Vehicle must achieve a fuel efficiency of **17 Km.** per litre.
10. The details of the make and year of manufacture of the vehicle, registration no., mileage (Km covered per litre) and name of the Driver, Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure-B).
11. The Quotation completed in all respect should reach the undersigned on or before 09.12.2025 by 03.00 P.M. and shall be opened on the same day at 05.00 P.M. in the presence of the bidders or their authorized representatives.
12. The application form of quotation/tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available with the Addl. Treasury Officer, District Treasury, Koraput between 10 AM to 01.00 PM on payment of Rs.100/- from 01.12.2025 to 09.12.2025 (Working Days only).
