





## AGREEMENT

This agreement is signed on this day the \_\_\_\_\_ January 2026 by the Registrar, as the First Party on behalf of the Vikram Dev University, Jeypore or the one part and

The Second Party affirms that:-

1. That, as per Letter No. \_\_\_\_\_/VDU Dated \_\_\_\_\_ of the Registrar, Vikram Dev University, Jeypore I have been provisionally selected as Asst. Professor/ Guest Faculty in \_\_\_\_\_ for the academic session 2025-26.
2. That, the Second Party is of fully aware of the terms and conditions of the engagement under the arrangement vide Letter No. 4478 Dated 01.02.2024 of the Commissioner-cum-Secretary to Govt., Higher Education Department, Odisha, Bhubaneswar and as per the Advertisement bearing Letter No. 3286/VDU/2025 Dated 31.12.2025.
3. That engagement under this agreement is purely temporary and that the Second Party shall not claim regularization of the engagement in any manner.
4. That, under this arrangement, honorarium shall be paid to the Guest faculties/ Retired Asst. professors with Ph. D degree to be engaged for PG courses against the vacant post of Asst. Professors @ Rs. 1000/- Per Class with a Ceiling limit of 60 classes per month (Rs. 60,000/-) and those without Ph.D for UG/PG courses against the vacant posts of Asst. Professors @ Rs. 750/- per class with the maximum of 60 classes per month i.e Rs. 45,000/-..  
That the Second party shall not claim any honorarium more than that stated in the honorarium table Point 3 & 4.
5. The tenure of engagement of the faculties under this arrangement shall be for a maximum period of 01 year or till the vacancies are filled in regular manner or Govt. instruction in this regard which ever is earlier.
6. That, the continuation of engagement shall be subject to performance during the quarterly review.
7. That the engaged retired faculties may continue with their teaching till they attend 70 years of age subject to periodical review of satisfactory performance.
8. The retired/ Guest Faculties will be allowed to avail 10 days leave in a year.
9. That, the payment of all statutory taxes including income tax will be the sole responsibility of the Guest Faculties/ Retired Asst. Professors themselves.
- 10 The authority reserves the right to cancel the engagement order of a faculty at any time if his/her services are found unsatisfactory and contrary to the terms and conditions reported by the department during the period of engagement.
- 11 A Guest Faculty/ Retired Assistant Professor shall be liable to be disengagement if any act of negligence, disobedience, misconduct or insubordination on their part is noticed or reported by the authorities of the University
- 12 Duties and Responsibilities of the engaged faculties:-
  - The faculties so engaged under this arrangement shall perform the following additional duties and responsibilities.
  - Academic work like teaching courses, conducting examination and research guidance. They will be entitled to guiding research projects of UG and PG students. However, in case of research projects or

Guiding Ph.D Scholars they will be eligible to become Co guides depending on their qualifications and experience.

- Conducting research and/or taking up sponsored research projects as per the rules and regulations of the funding agency.
- Launching continuing education program in new and emerging areas.
- Organizing/attending National/International Conferences/Seminars / Symposia / Workshops with a co-organizer from the University / college but without any financial commitment from the University.
- Undertaking knowledge-based advisory / consultancy assignments in accordance with the University guidelines.
- Accepting invitations and delivering guest lectures at other institutions.
- Participation in academic/research Committees at the University and elsewhere, when required.
- However, they shall not be eligible for holding administrative or financial responsibilities.

### 13 Review of Performance

The performance of the retired faculties/ guest faculties/ other faculties under this arrangement shall be reviewed on quarterly basis by the University. If the performance and/or official conduct is found unastafactory, then he/she may be disengaged forth with by the Head of the Department furnishing a report to the Vice-Chancellor of the University.

Being aggrieved, the retired teacher/guest faculty may prefer appeal within 15 days time to the Vice-Chancellor of the University whose decision shall be final and binding upon both the parties (i.e retired teacher/guest faculty and the Head of the Department).
