Terms and Conditions

1. The Sealed tenders in prescribed proforma should be super scribed as "for engagement of a Transport Contractor to provide services for transportation of Oxygen Gas Cylinders and other Gas Cylinders required for use in the SLNMCH, Koraput.)"for SLNMCH, Koraput are to be submitted on or before Dt: 16.03.26 at **5:30 P.M.** through Regd. post/ Speed post/Courier at the Office of Superintendent, SLN MCH, Koraput. Tender will be opened in the chamber of Medical Superintendent, SLN MCH, Koraput on Dt: 17.03.26 at **11.30 A.M.** The tender/bidder or their authorised representative are allowed to be present during the opening of the tenders, if they so like. The tender document received beyond the scheduled date and time will not be considered under any circumstances.
2. The Tenderer should furnish the EMD in favour of Superintendent, SLNMCH, Koraput of Rs.50000/- (Rupees Fifty Thousand only) attached along with tender documents. The EMD will be forfeited, in case the successful tenderer fails to execute the order within the stipulated period.
3. EMD of successful tenderers will remain with the undersigned as performance security till expiry of valid period of the tender and the unsuccessful bidders can take back their EMD on submission of an application to the Superintendent, SLN MCH, Koraput seeking for so.
4. The selected tenderer shall not discontinue Transportation service during the contract period under any circumstances; otherwise the EMD (Performance Security) will be forfeited without any correspondence.
5. After scrutiny of the technical bids by the Committee, the price bid of the successful Firms who qualifies in the technical specification will be opened by the committee on the date mentioned or the date as fixed by Superintendent in presence of either the tenderers or their authorized representatives. If any tender or their authorised representatives fails to turn up at the time of opening of the tenders, the process will continue as usual.
6. The agency shall transport the empty Cylinders from O/o the Medical Superintendent, SLNMCH, Koraput to the gas-plant in and return with loaded gas cylinder to the office.
7. The approved transporter has to pick up the empty cylinder from the Pharmacist/ Gas Technicians or duty of the oxygen plant of the SLNMCH, Koraput soon after receipt of orders

in this regard and after refilling the cylinders, the transporter has to deliver the picked cylinders to the pharmacist/gas technician on duty of the oxygen plant of the hospital.

8. They should provide adequate labour for loading and unloading of both sides during transportation, the labour charges of which should be inclusive in the transporting cost. The transportation cost so quoted by the bidder should be inclusive of all taxes and toll gate charges with loading and unloading charges of both side.
9. It is the responsibility of transport vehicle to count the cylinders at the time of loading from oxygen store as well as receiving filled cylinders from Oxygen refilling plant and delivering filled cylinders at Oxygen store. In case of any missing cylinders, same will be recovered from Transport Agency.
10. In case of vehicle breakdown, transport agency will engage alternate vehicle immediately at breakdown site to transport cylinders.
11. At no point of time the agency shall be absolved of responsibility in providing the transportation to the life-saving gas manifold unit. If they do so necessary criminal proceedings shall be initiated and shall be black listed.
12. The vehicle should be on road worthy condition in all respect for operation in accordance to the motor vehicle act and rules made under the State Govt. as may be applicable and amendment from time to time. However, the vehicle shall not be more than 3 years old from the date of initial registration.
13. The transportation shall be made on credit basis and the payment will be made monthly on submission of bills in triplicate to the undersigned. However if any circumstances it prevails for delay of payment they are requested to bear with co-operation.
14. The successful bidder after getting work-order shall have to seek the instructions provided to him as to where and when and how much quantities of cylinders will be dropped & collected from time to time.
15. At times in emergency when the supplier will drop the cylinders at the destination, the transporter should not claim any dues for the same
16. The bidder will be responsible by abiding itself by the national law including rules relating to manpower, services etc. offered by the bidder.
17. The Job holder shall not claim any place in the campus for open office or garage place for vehicle and the parking of the vehicle will be at of the owner risk.
18. The bidder shall be responsible for any legal actions, suits claims and demands brought or made against it in respect of anything done or committed to be done by the bidder in execution of or in connection with the work of this contract and against any loss or damage to

SLN MCH, koraput and its beneficiary in consequence to any action or suit being brought against the bidder for anything done or committed to be done in the execution of this contract. The bidder will abide by the job safety measures prevalent in India and will free the SLN MCH, koraput from all demands or responsibilities arising from accidents of loss of life, the cause of which is the bidder's negligence. The bidder will pay all indemnities arising from such incidents without any extra cost to the SLN MCH, koraput and will not hold the SLN MCH, koraput responsible or obligated. The bidder will be responsible to defend such suit, claim or against legal liability. The SLN MCH, koraput will at the discretion may jointly or singularly defend such suit, claim or against legal actions.

19. Failure to fulfill any of the conditions given above shall render the tender for rejection.
20. If any information or documents furnished by the tenderer found to be misleading/ incorrect at any stage their tenders will not be accepted.
21. The committee is not bound to accept the lowest rate and Highest discount offer considering the technical aspects.
22. The tender will be valid for one year from the date of approval/ till finalization of next tender.
23. Any condition of tenderer will not be accepted.
24. Original documents may be produced for verification if asked for.
25. The Superintendent, SLN Medical College & Hospital, Koraput reserves right to accept/ reject/ cancel any or all the tenders in full or part without assigning any reason thereof.
26. Tenderer who has been blacklisted either by the tender inviting authority or by any state Govt. Or Central Govt. Organisation should not participate in the tender during the period of blacklisting, and the tenderer should submit the undertaking about of non blacklisted by any authority in non judicial stamp paper duly attested by notary.
27. The payment will be released subject to availability / allotment of funds. Payment shall be made on receipt of the stock entry certificate on the body of the bill/invoice from the store. No advance payment towards cost of items will be made to the supplier,
28. The tender documents should be clearly written/ typed without any correction, interpolation and over-writings etc and each page of the tender should bear the dated, signature and page number of the tenderer.
29. The price quoted should be final and shall not be subject to any change during the validity of the tender. In the event of bidder fails to supply / reluctant/ refusal to supply the items, the Medical Superintendent, SLNMCH, Koraput has reserve the right to impose penalty @ 5% of the order value and also forfeited the EMD/ Security Deposit.

30. In case of non-supply by any approved lowest quoted Firm within 2 days of supply order, the Medical Superintendent can offer any of L-2 Firms to provide the transportation service at L-1 rate (lowest approved rate) for providing uninterpreted service to patients.
31. The tenderer should adhere to the terms & conditions and submit the bids in given prescribed proforma failing which the tender paper will be cancelled.
32. All legal disputes, if any relating to purchase etc are subject to jurisdiction in the courts of law situated at Koraput, Odisha.
33. Each page of the tender document should be self-attested by the tenderer.
34. If as a result of post payment audit any overpayment has detected in respect of supplied goods against this tender, it shall be recovered by the Medical Superintendent, SLNMCH, Koraput.
35. The awarded bidder for respective items must be entered into contract agreement (as per Annexure with the terms and conditions within 15 days of issue of awarded letter.
36. Selection of Bidder.
- The bidder meeting, all the eligibility criteria as given in (Annexure-1) will be declared technically qualified in technical evaluation.
 - All the technically qualified bidders will be considered for opening of financial bid.
 - The price bid of all the technically qualified bidders will be opened for scrutiny of financial bid
 - The bidder quoting the lowest price taking together comprehensively in all two categories 1. Labourcost 2. Transportation cost will be declared as L1 bidder
