

**RESOLUTION NO-07**  
**Home Guards Organization Koraput**

**Subject: Disqualification of candidature of provisionally selected Home Guard Durjyadhana Dadia, S/o- Sadan Dadia, PS- Machkund, Dist- Koraput selected vide Koraput district Home guard Organisation selection list published vide Notification No- 28/HGs, Dtd- 16.01.2026 vide SI. No. 94 on grounds of antecedents, suppression of material facts and unsuitability.**

Whereas, the applicant Durjyadhana Dadia, S/o- Sadan Dadia, PS- Machkund, Dist- Koraput was provisionally selected for enrolment as Home Guard during the recent Home Guard enrollment process conducted in Koraput district;

And whereas, on verification of records and antecedents, it has come to notice that the applicant was earlier discharged from the Home Guards Organisation vide Home Guard Organisation, Koraput DO No- 24, Dtd. 19.09.2024

And whereas, credible reports and inputs received during antecedent verification disclose serious allegations against the applicant relating to:

alleged participation in transportation of contraband Ganja,  
alleged association and linkage with organised Ganja mafia, and  
alleged acceptance of illegal gratification,

which, if true, are acts gravely prejudicial to discipline, public order and the image of the Home Guards Organisation;

And whereas, it is specifically noted that no criminal case has been registered against the applicant in respect of the above allegations; however, enrolment as Home Guard is not a matter of right, and suitability is required to be assessed on the basis of overall antecedents, past conduct and trustworthiness, independent of criminal prosecution;

And whereas, the nature of the allegations, coupled with the applicant's past discharge from the Home Guards Organisation, gives rise to serious doubt regarding his integrity and devotion to duty, rendering him unsuitable for enrolment in a disciplined voluntary force assisting the Police Administration;

And whereas, elected representatives and local residents have raised strong objections against the selection of the applicant, expressing serious concern over his antecedents and the likely adverse impact on public confidence;

And whereas, it is further found that the applicant suppressed material facts relating to his earlier discharge from the Home Guards Organisation while submitting his application, amounting to misrepresentation and concealment of facts, which constitutes a valid and independent ground for disqualification of candidature under recruitment norms and settled principles of administrative law.

And whereas, enrolment of the applicant in the above circumstances would be against public interest and contrary to the objectives and spirit of the Odisha Home Guards Act, 1961 and the Rules made thereunder. His existence in the Home Guards Organization will adversely impact the moral of the other volunteers and will send a negative message among the aspirants.

It is pertinent to mentioned here that the selection committee which was formed in accordance with the Home Guards Circular Order no 01/2025 preserves all the rights to cancel the candidature of any candidate ant any stage of the enrollment process if any discrepancy found.

Basing upon the above facts and circumstances after threadbare discussion in the above matter the Selection committee unanimously zeroed upon the following points.

1.The candidature of the above-named applicant is hereby disqualified and cancelled forthwith. The provisional selection/enrolment, if any, stands withdrawn with immediate effect. The disqualification is based on unsuitability arising out of antecedents, doubtful integrity, and suppression of material facts, and not on any criminal conviction.

This order is passed in the interest of discipline, integrity, public order and maintenance of public confidence in the Home Guards Organisation, without prejudice to any other action permissible under law.


