Sealed Quotation are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing of 01 nos of Non AC/ AC Diesel Driven Vehicles (TUV300/ Bolero/ Sumo Gold/) having sitting capacity not more than ten including driver, which shall conform to the Terms and conditions (Annexure-II) for official use in this Tahasil Office, Jeypore on monthly rent basis for supervision of Revenue works.


1. The vehicle must be in Road Worthy condition shall not be more than 2 years old from the date of initial registration and must have valid Commercial License, Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle. This includes newly booked vehicle(Copy of Quotation must be attached) with an undertaking in stamp paper before Notary Public that “ **If I will be successful in the bidding process, then a brand new vehicle(aforementioned model) will be provided by me within 15 days**”.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature & must have at least 3 years experience in driving.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank draft drawn in favour of Tahasildar, Jeypore payable at State Bank of India, Jeypore Main Branch and be submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the General bid information (including Driver's monthly salary, excluding fuel & lubricants) not exceeding Rs.37200/-
6. The Vehicle must achieve a fuel efficiency of at least 10 Kms. Per liter.
7. The details of the make and year of manufacture of the vehicle, registration no. mileage (Kms. Covered per liter) and name of the driver with Driving License No and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (Annexure-III).
8. The Quotation completed in all respect should reach the undersigned on or before 8.5.2026 through registered post or Speed post only by 1.00 p.m and shall be opened on 11.5.2026 at 10.00 am onwards in presence of the bidders or their authorized representatives. (**Applications received though Courier or by hand will not be entertained**)
9. The application form of quotation/tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available at Tahasil Office, Jeypore on payment of Rs.100/- from 29.4.2026 to 7.5.2026 on working day & during office hours only.

10. The eligible bidder shall commence the services from the date of agreement and shall continue to provide the services for one year (as per the agreement made with the Tahasildar, Jeypore).

11. Other term & conditions are available in the office of the Tahasil Office, Jeypore.


